(a) <u>Auditor:</u>

"That the firm of Deloitte LLP be the auditors for the school division for the 2016 year."

(b) <u>Agent of Record (Insurance Agent or Broker):</u> Recommendation:

(c) <u>Solicitor:</u>

(a) <u>Regular meeting date, hour and place:</u> Recommendation:
