

RECEPTIONIST

PURPOSE:

This position assists management to achieve an efficient operation in the Education Centre through exemplary performance in a variety of receptionist, office management, and clerical functions and in doing so ensures the safety and security of confidential information and documents.

This position reports directly to the Executive Assistant.

DUTIES AND RESPONSIBILITIES:

- \Rightarrow Perform receptionist duties such as answering incoming calls, ascertaining the nature of the call and directing to appropriate personnel in a professional and courteous manner.
- \Rightarrow Greet all clients, respond to their inquiries and direct them or refer them to the appropriate meeting location or staff member.
- \Rightarrow Program and upkeep the voice mail system and revise switchboard voice messages as required.
- \Rightarrow Manage and maintain the electronic booking system for scheduling of all seminar rooms at the Education Centre and ensure appropriate information is posted as required.
- \Rightarrow Ensure that basic maintenance of photocopier, fax, Risograph, and mail machine is handled including contacting appropriate companies for maintenance as required.
- ⇒ Process incoming/outgoing mail, courier deliveries and faxes on a daily basis. Maintain records of all transactions and prepare and submit reports as required.
- \Rightarrow Ensure adequate inventory of all required office supplies is available for Education Centre staff. Requisition office supplies on-line and distribute to appropriate personnel.
- ⇒ Program the doors of the Education Centre to ensure that they are unlocked in the morning, secured at noon hour and then again after work as well as programmed for other meetings and functions as required.
- ⇒ Perform the data entry required for all leaves of staff based at the Education Centre and Maintenance Centre.
- ⇒ Act as Contact person for all Education Centre and Maintenance Centre staff for sick leave. Ensure that all appropriate personnel are notified when the staff member is sick.
- \Rightarrow Administer all requests for treaty entitlements and drafting letters for signature by the Executive Assistant.
- \Rightarrow Field all Freedom of Information requests and direct or handle the requests as required.
- \Rightarrow Maintain and oversee the central filing system.
- \Rightarrow Assist staff with the creation of specialized documents.
- \Rightarrow Handle minimal amounts of cash for small items received from staff.
- ⇒ Comply with any and all applicable Board Policies, guidelines and practices, and legislation and regulatory requirements.
- \Rightarrow Perform other related duties as assigned.



QUALIFICATIONS: EDUCATION, TRAINING & EXPERIENCE:

⇒ Typically the required knowledge, skills and abilities are obtained through successful completion of Grade 12 coupled with at least one year of Office Education or secretarial training from a post-secondary institution acceptable to the Board.

REQUIRED LICENCES, CERTIFICATIONS & REGISTRATIONS:

 \Rightarrow Minimum typing speed of 65 wpm (certificate of proof required).

KNOWLEDGE, SKILLS & ABILITIES:

- \Rightarrow Demonstrated knowledge in the operation and basic maintenance of office equipment.
- \Rightarrow Demonstrated knowledge of methods and procedures used in maintaining an office.
- \Rightarrow Working knowledge of and ability to operate within Board policies and procedures.
- \Rightarrow Ability to maintain accurate records and documentation and provide recommendations to the Executive Assistant.
- \Rightarrow Excellent interpersonal and communication skills, both verbal and written.
- \Rightarrow Working knowledge of current technology and software associated with the duties and responsibilities of this position.
- ⇒ Ability to work independently with minimal on-site supervision demonstrating sound judgement and decision-making skills to ensure quality of work meets expected standards.
- \Rightarrow Ability to establish and maintain effective working relationships with all staff, students and the public demonstrating tact and diplomacy.
- \Rightarrow Ability to conduct oneself in a manner appropriate to an educational institution that provides services to children including demonstrating strict attention to confidentiality of school operations and student information.

ADDITIONAL INFORMATION:

- ⇒ A security background check including both a Criminal Record Check and a Vulnerable Sector check will be required.
- \Rightarrow Must participate in applicable safety training, work-related professional development, inservice, or courses of study.
