Each year, the Board contracts an external auditor to review the division's financial management and records. At its recent meeting, the auditing firm of MNP shared the findings of its audit. The auditor indicated that the SRPSD finances are in good order. There was strong evidence of effective and appropriate fiscal management and accounting practices. As a result, MNP issued a "clean audit" for the division.
