- Update on partnerships was provided.
 - Kisewatotatowin working group meeting focused on work plan update and finalization.
 - Saskatchewan Rivers' presentation on November 25 was well received by the Ministry and ISSI participants from around Saskatchewan.
 - City Engagement session on November 26 was a productive meeting.
 - Refugee settlements are underway in the province. Key information and activities was provided. A trustee requested additional information regarding the Settlement Workers in the Schools (SWIS) and the number of English as Additional Learners in the school division.
- SRPSD Action team that is leading the response to the Joint Committee on Student and Teacher met recently and is investigating ways to reduce inefficiencies and increase job satisfaction among teachers.
- SRSD Professional Development chairs met to review the operations of the school PD committees.
